**Invitation to Bid for Various Drugs and Medicines**

The Central Mindanao University through the SIF intends to apply the sum of Six Hundred One Thousand Five Hundred Sixty Seven Pesos Only (P. 601,567.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Various Drugs and Medicines. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The Central Mindanao University now invites Bids for Various Drugs and Medicines. Delivery of the Goods will be 5-15 days after receipt of Notice to Proceed. Bidders should have completed within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations of Republic Act 9181 (R.A. 9181), otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138).

Interested Bidders may obtain further information from Central Mindanao University and inspect the Bidding Documents at the Bids & Awards Office from 7:00 a.m. to 4:00 p.m. in "Upsilon Hall," March 3, 2012.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee in the amount of One Thousand Eight Hundred Five Pesos Only (P. 1,805.00). The method of payment will be in cash. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids. Pre-Bidding Conference on February 23, 2012, 2:00 pm.

Bids must be delivered to the address below on or before March 6, 2012, 10:00 am. All Bids must be accompanied by a Bid security in the form of Cash and in the amount of Twelve Thousand Thirty One Pesos and Twenty Three Centavos (P. 12,031.23).

Bid Opening shall be on before March 6, 2012, 10:00 am at the BAC Office, Central Mindanao University, University Town, Musuan, Bukidnon. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late Bids shall not be accepted.

The Central Mindanao University reserves the right to accept or reject any Bid, to amend the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.






