**CONTRACT OF AGREEMENT
 (GF-PB-19-076)**

This AGREEMENT entered into at Musuan, Maramag, Bukidnon by and between the Republic of the Philippines, through the *Central Mindanao University represented by DR. JESUS ANTONIO G. DERIJE in her capacity as University President, hereinafter referred to as PARTY OF THE FIRST PART.*

And

XY BUILDERS of Purok 2, Patag, Bagontaas Valencia City, Bukidnon, represented by **JERSON H. LIMOCON** in his capacity as Proprietress/Manager hereinafter referred to as PARTY OF THE SECOND PART.

WITNESSETH

WHEREAS, the PROCURING ENTITY is desirous that the CONTRACTOR execute the works under General Funds- **Completion/Repair Old Nursing Building**, hereinafter called "the works", and the PROCURING ENTITY has accepted the calculated Bid of the CONTRACTOR for the execution and completion of the Works within Three Hundred Sixteen (316) calendar days at the calculated unit bid prices shown in the following Bill of Quantities, or a total Contract price of **Two Million Two Hundred Forty Five Thousand Two Hundred Fifteen Pesos and 18/100 (Php2,245,215.18).**




